



ADVISORY ON THE USE OF ONLINE SYSTEM IN ALL TRANSACTIONS INVOLVING APPLICATION OF PERMITS AND OTHER DOCUMENTS

TO ALL OUR VALUED CLIENTS:

As the deadly and highly contagious COVID-19 continues to be a threat until no viable vaccine is available, we would like to inform all our valued clients that we shall impose socially distant transactions in our Office. Face-to-face interactions pose high risk of contracting the disease as the modes of transmission are by way of droplet and contact either direct or indirect. Physical distancing of 2 meters in the Office is unlikely to be practiced due to limited space.

In view of this, we highly encourage all our valued clients to maximize the Online System for your permitting and other needs. The following documents can be done through online system:

- For ECC Minor Amendment, Regional EIS and EPRMP application, Category C (Projects prior to 1982 and Environmental Enhancement and Mitigation Projects), you may send the scanned copy of your documents/application requirements for our evaluation and we will send a feedback for your next step of action.
